SUBJECT: PROFESSIONAL DEVELOPMENT AND TRAINING: "LEGISLATIVE **ADVOCACY DURING COVID" WEBINAR** (PAF 21-012(24))

On January 7, 2022, we attended the Pacific Law Institute webinar "Legislative Advocacy During Covid." Members of the Hawai'i State Senate and House discussed procedure and structure for the 2022 Legislative Session.

With the Capitol closed, Senate and House committees are following a virtual format for hearings. The best way to follow any changes to the virtual model, provide testimony, and receive updates is through creating an account at the Legislature's website at capitol.hawaii.gov.

There will not be limitations on the number of testifiers; however, time-constraints may be imposed at the discretion of committee chairs. Written testimony must be submitted to ensure receiving the Zoom link to join the hearings for verbal public testimony presentation. Submitting written testimony at least 24 hours in advance is important. It is also important to show up to the meeting early to troubleshoot any technical issues ahead of the meeting. Legislators have been advised not to take any in-person meetings, but are accessible by email, and requests for virtual meetings can be made.

The Legislature is committed to updating the meeting protocols if the and COVID-19 concerns subside, Senate Ronald D. Kouchi and Speaker of the House Scott K. Saiki said. All updates will be readily communicated and available through the website.

Legislators said this is going to be a critical year on some serious long-term and long-standing issues. They also referenced the State Supreme Court's decision to invalidate the "gut-and-replace" system in League of Women Voters of Honolulu v. State of Hawaii on November 4, 2021. They said the opinion will not require many changes to the legislative process, except that public testimony will be received on substantive changes to legislation.
